

ATTENDED FUNERAL (funeral director's charges only)	£2960.00
This is a funeral where family and friends have a ceremony, event or service for the deceased person at the same time as they attend their burial or cremation.	
Taking care of all necessary legal and administrative arrangements	£1400.00
Collecting and transporting the deceased person from the place of death (normally within 15 miles of the funeral director's premises) into the funeral director's care	£295.00
Care of the deceased person before the funeral in appropriate facilities. The deceased person will be kept at either the funeral director's branch premises or at other non-branch premises	£260.00
Providing a suitable coffin – this will be made from Semi polished wood coffin	£490.00
Viewing of the deceased person for family and friends, by appointment with the funeral director (where viewing is requested by the customer)	£85.00
At a date and time you agree with the funeral director, taking the deceased person direct to the agreed cemetery or crematorium (normally within 20 miles of the funeral director's premises) in a hearse or other appropriate vehicle	£430.00

UNATTENDED FUNERAL	
This is a funeral where family and friends may choose to have a ceremony, event or service for the deceased person, but they do not attend the burial or cremation itself.	
Burial (funeral director's charges only)	£1100.00
Cremation (funeral director's charges plus the cremation fee)²	£1400.00

FEES YOU MUST PAY	
For an Attended or Unattended burial funeral, the burial fee . ¹	From £2880
In this local area, the typical cost of the burial fee for local residents is: For a new grave, you will also need to pay for the plot; for an existing grave with a memorial in place, you may need to pay a removal/replacement fee. In addition, the cemetery may charge a number of other fees.	
For an Attended cremation funeral, the cremation fee . ²	£615.00 –
In this local area, the typical cost of a cremation for local residents is:	£1040.00

¹ This fee (which is sometimes called the interment fee) is the charge made for digging and closing a new grave, or for reopening and closing an existing grave.

² In England, Wales and Northern Ireland, you will usually need to pay doctors' fees as well. This is the charge for two doctors to sign the Medical Certificates for Cremation.
